INSPECTION

Upon receiving your Drive Medical Model 18450 Compressor, inspect the packaging for signs of damage in transit. Inspect the unit thoroughly. Any sign of damage, external or internal, should be reported to your Homecare Dealer immediately.

GENERAL INFORMATION

This manual provides information necessary to operate the Drive Medical Model 18450 50 PSI Compressor. This unit is designed for efficient, continuous high pressure performance. The Model 18450 Compressor provides high pressure which clinical studies have indicated are required for optimal particle size (2 microns or less).

The unitoperates quietly and effectively due to the unique design of the WOBL piston. This unit operates using standard 120 VAC current, it is easy to clean, very low maintenance, compact, light-weight, and portable. The unit is designed for use with:

- -Compatible with hand-held nebulizer system.
- -Heated nebulizer.
- -Dual action humidifier/nebulizer.
- -Pediatric mist tent.
- -High output pneumatic nebulizer .
- -Deluxe nebulizer with oxygen diluter.
- -Child / adult mist tent.
- -Large Volume Nebulizer.



OPERATING INSTRUCTIONS

INITIAL POSITIONING AND INSTALLATION

- 1. Select a suitable location for the unit near a 120 VAC, 15 Ampere, grounded power outlet.
- 2. Grasp handle on top of cabinet and position the unit so that operating controls are Accessible to the user and back of unit is away from wall.
- 3. Make certain that the power switch located in the center of the control panel is in the OFF position (Figure 1) and plug power cord into grounded power outlet or grounded adapter.
- 4. Be certain that all connections to outlet (i.e. tubing, nebulizers, etc.) are snug and not leaking aerosol.
- 5. When used in conjunction with mist tents, etc., place unit outside of tent and place unit at a level below discharge end of the delivery tubing.

OPERATION

- 1. Press Power On/Off switch to ON position (figure 1).
- 2. Connect the equipment you intend to use with the Drive Medical Model 18450 compressor and then adjust the pressure that the unit is delivering by adjusting the regulator (figure 1) as follows:
 - a. Pull regulator knob out to unlock adjustment.
 - b. Turn dial of regulator to desired pressure.
 - clockwise increase pressure
 - counter clockwise decrease pressure
 - c. Push knob towards unit locking regulator pressure.

...Observe the pressure gauge and adjust regulator up or down to desired output pressure.



ROUTINE MAINTENANCE

A. REPLACING AIR INTAKE FILTER (FIGURE 2)

NOTE: Perform this procedure as needed. Replace every 12 months or as needed. Frequency will depend upon the environment the 50 PSI Compressor is used in.

Pull aire intake filter out from the front of unit and replace a new one when dirty. Do not wash it.




A. REPLACING CABINET FILTER (FIGURE 3)

NOTE: Perform this procedure as needed. Replace every 12 months or as needed. Frequency will depend upon environmental conditions.

- 1. The rear filter may be periodically rinsed with water to remove any debris or dust. Let air dry before replacing.
- 2. Take out and discard existing cabinet filter at the back of the cabinet as necessary.
- 3. Insert a new cabinet filter at the back of cabinet.



C. COMPRESSOR CLEANING

Wipe the compressor cabinet with a clean cloth and any commercial available disinfectant.

If the Drive Medical Model 18450 series compressor malfunctions, refer to the trouble shooting chart below for probable cause and remedy. If the unit fails to operate correctly after using the troubleshooting chart below, contact your Homecare Dealer for further assistance.

TROUBLE SHOOTING CHART

TROUBLE	PROBABLE CAUSE	REMEDY
A. Unit not operating	Plug not firmly in wall. No power at wall outlet	Check plug at outlet . Check power source, fuse in house
B. Limited air flow	1. Faulty Delivery Tubing.	Disconnect delivery tubing at outlet . If proper flow is restored, checkequipment and tubing for obstructions or kinks. Replace if needed.
	2. Leak.	2. Check fitting at outlet and tubing.
	3. Blocked intake filter.	3. Replace air intake filter.
